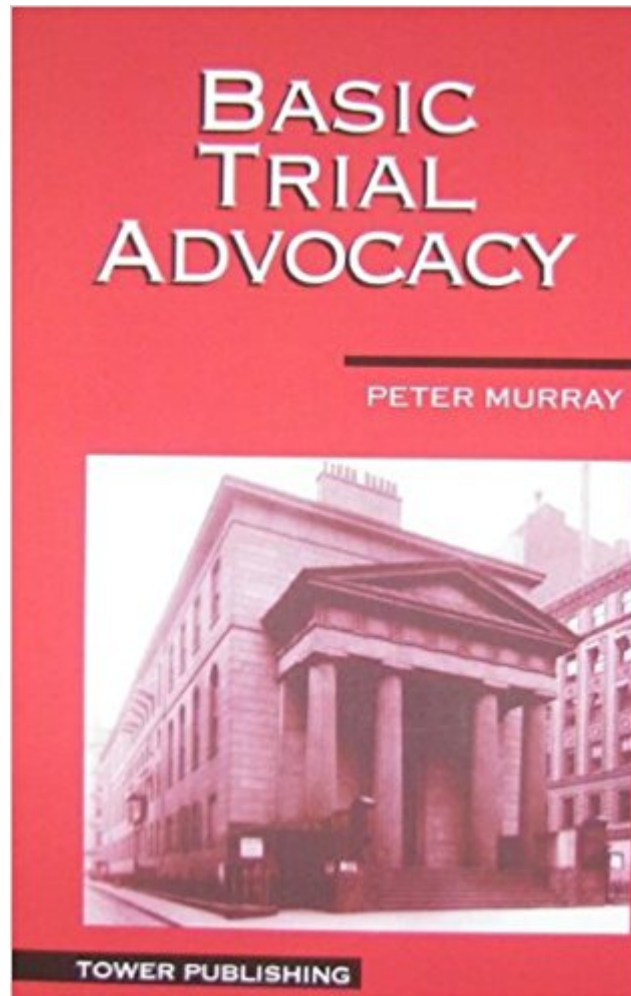

Basic Trial Advocacy has been published after the author's fifteen plus years of active teaching of trial advocacy, largely at Harvard Law School, but also at the University of Maine School of Law and in various NITA, law firm, and pro bono educational programs for both law students and young lawyers. This book reflects the understanding of why trial lawyers do what they do. Systematic understanding of the trial advocacy process will enable a new lawyer to better apply the experience and observations that are available to develop the skills of trial practice. This publication is designed for use in law school trial advocacy or trial practice courses. It is also written to be useful to lawyers in connection with firm-sponsored or independent trial advocacy training.
