

Austria, Germany, And The Cold War: From The Anschluss To The State Treaty, 1938-1955



Synopsis

In the 'Moscow Declaration' of 1943 the Allies officially propagated the notion of Austria as the first victim of Hitlerite aggression and announced their intention to set up a "free and independent Austria" after the war, which finally happened in 1955. By questioning why it took so long to get to this point, the author addresses issues such as the victim thesis, Austrians as perpetrators, Austrian anti-Semitism and official attempts to mitigate its effects after the war. He discusses the various proposals for post-war Austria and connects for the first time the issues of Anschluss, German question, Cold War, and the State Treaty. He makes it clear that the question of Austria was from the very beginning inextricably linked with the more important question of Germany.

A very interesting look at a corner of the post-war world so often ignored. Well-written with excellent research and arguments. It also offers some key insights into the evolution of post-war Germany in the thinking of the Four Powers. My compliments to the author: Austria is considered , wrongly, a second class country during the Cold War. In reality it is one of the major place where West and East compete. The short book is very clear, well written and helps to understand why neutralized Austria is so important for the destiny of Germany and Italy. It is one of the few cases when the Soviets leave a country free (very actual in the fight for the independence of Ucraina) . The links with the Italian Peace Treaty and the sort of Trieste (under Anglo-American administration until 1954) are really fascinating: Austria and Italy are part of a game where Germany is the main prize. Now we know why the Austrian-Italian border dispute has been settled in favour of Italy, soon to became a member of NATO.

I expected at least a brief summary of the main clauses of the treaty that allowed Austria to remain out of the Iron curtain ,but not a word.A very important missing link to fully understand this moment in history
